

# BEWARE OF IDENTITY THEFT WHILE TRAVELING

Whether you're away on business or vacationing with your family – keep your identity safe and sound. Follow the tips below to keep yourself and your information secure and know that IDProtect is here to help if something happens while you are traveling:

- Let your credit/debit card company know that you'll be traveling, how long you'll be gone for and where you're going (especially if you're leaving the country).
- Clean out your wallet don't keep anything in there you don't need. Don't take your checkbook– instead use credit cards for purchases. Be sure to register your credit and debit cards with IDProtect before you travel – go to Card Registration to learn more about this service.
- Check your accounts regularly for suspicious activity. Be sure to activate Monitoring with IDProtect before you travel so that you can be alerted of key changes to your credit file – go to Monitoring to learn more.
- After you return home check your accounts, and then check them again to see if you notice any suspicious charges.
- Don't post travel plans on social networking sites. Don't alert potential identity thieves that you're leaving home for an extended period of time and don't upload vacation photos while you're out of town.

As part of our continuing effort to bring the best technology and service to our members, Russell Country FCU is upgrading our fraud Detection and Notification System. The new system will provide faster, more immediate attention to notify our members when fraud is suspected. The notification portion of the system includes a state-of-the-art automated assistant to help our members review transactions and confirm their spending activity on their Debit MasterCard and/or ATM Cards.

For example, if you are traveling, you may receive a notification call from our automated assistant, whom we have nicknamed Jill, please work with her to answer questions regarding recent card activity. Please also be aware that our Card Member Security team that provides fraud alert management is available 24 hours per day, 7 days per week, should you need assistance from a live agent.

If suspicious transactions are identified as fraudulent, calls will be transferred to our outstanding member support team at Card Member Security to help you take the necessary precautions to protect your cards and related accounts. If the recent activity is legitimate, members will be able to close the case with the phone attendant using their touch-tone phone.

# LATEST UPDATE: DATA PROCESSING SYSTEM UPGRADE



#### The process of converting to a new data processing system has begun!!!

After running on the same data processing system for more than 20 years it's time to upgrade to a faster, more efficient, and more functional data processing system.

Having completed the preliminary conversion steps, beginning in January, we've moved into the product and service stage where we map our existing products and services to the new system. This process will take us into the latter part of spring, followed by the latter part of spring, followed by the system training phase that will begin in late summer, followed by the testing phase beginning in September.

# These steps lead us to the 'Go-Live' date of November 1, 2015.

From start to finish the entire process takes 44 weeks. As we move deeper into the conversion process you'll see gentle reminders of the conversion in each of our lobby's, and we'll continue to remind you through newsletter articles, statement messages, Facebook posts, and throughout our website.
