Guidelines regarding the Board of Director election process:

You must be at least 18 years of age to be eligible to vote or hold elective or appointed office. Members who are eligible to vote must be of record on or before August 26, 2022. Voting will be by mail ballot only. Ballots will be mailed to members during the week of September 10, 2022. Ballots must be returned and postmarked no later than midnight October 10, 2022, however the election will not be conducted by mail ballot when there is only one nominee for each position to be filled. There will be no nominations from the floor.

Nominations by Petition:

Nominations by petition will be accepted until midnight of September 15, 2022. Only single nominees may be presented on a single petition by individuals wishing to be on the Annual Meeting Ballot. A minimum of 100 Russell Country FCU members' signatures must be obtained for the petition to be valid. If there are no petitions, there will be no mail ballot and the Nominating Committee nominees will be declared at the Annual Meeting as having been elected by acclamation.

The following statement must accompany any petition:
