- You must be a member of record prior to **March 9, 2020** to be eligible to vote.
- Ballots will be mailed to members the week of **March 23, 2020**.
- All ballots must be returned to a Russell Country FCU office or postmarked no later than midnight of **April 21, 2020** to be valid.
- Voting will be by ballot only unless there is only one nominee for each vacant position.
- There will be no nominations from the floor.

Nominations by Petition

Nominations by petition will be accepted until midnight of **March 30, 2020**. Only single nominees may be presented on a single petition by individuals wishing to be on the Annual Meeting Ballot. A minimum of 100 Russell Country FCU members' signatures must be obtained for the petition to be valid.
