IMPORTANT MOBILE DEPOSIT UPDATE

Effective July 1, 2018, Russell County Federal Credit Union will be requiring all checks deposited through our mobile app to have the following endorsement on the back of the check:

- 1. Member Signature
- 2. "For Mobile Deposit at RCFCU Only"
- 3. Account number (optional)

Checks that are not properly endorsed will be rejected and funds will not be deposited into your account. If rejected due to improper endorsement, a Russell Country Federal Credit Union representative will call you to discuss how to redeposit your check.
